BUDDHIST GLOBAL RELIEF WORKS WITH LONGTIME PARTNER ACTION AGAINST HUNGER TO ADDRESS THE UNDERLYING CAUSES OF MALNUTRITION AMONG CHILDREN IN 35 VILLAGES IN MPWAPWA DISTRICT OF THE DODOMA REGION BY INCREASING THE PRODUCTION OF NUTRIENT-RICH CROPS AND THE CONSUMPTION OF THESE FOODS TO IMPROVE DIETARY DIVERSIFICATION. THE PROJECT WILL TRAIN 1,800 SMALL-HOLDER WOMEN FARMERS IN CLIMATE-SMART AGRICULTURE, POST-HARVEST MANAGEMENT, AND FOOD PRESERVATION.
